#### PRIVACY & DATA PROTECTION POLICY

Future Faces (Lutterworth) Limited is committed to safeguarding the privacy of our clients. This Privacy Policy explains how we collect, use and store any personal information.

# WHAT INFORMATION DO WE COLLECT ABOUT YOU?

We collect, store, and use information about you when you register/enrol with us or place an order for products and services. We also collect, store and use information when you voluntarily complete customer surveys, provide feedback and participate in competitions or events. The personal information we collect, and use may include:

- Full name and contact details (e.g., home, work, email and web addresses, home and mobile telephone numbers)
- Records of products and services purchased
- Bank and payment details to administer payments
- Date of birth and/or age for safeguarding children and other legal requirements
- Education, professional qualifications/memberships, insurance details, DBS certificate, work history and any references
- Personal information about persons connected to you such as legal guardians, legitimate carers and referees. You must have their authority to provide their information to us.
- Photographs, for promotional purposes, with appropriate permissions and credits only.

## HOW WILL WE USE THE INFORMATION ABOUT YOU?

We collect information about you to process your order, manage your account and use this information to provide the services requested and to maintain guarantee records. If you are entering for an examination with Trinity College London (TCL) either personally or for a child under your supervision basic information will be shared with TCL as is necessary and required to complete your order for examination entry.

We may also use your personal information.

- If you agree, to send you marketing information about other products and services we think may be of interest to you.
- send you non-marketing commercial communications.
- send you email notifications that you have specifically requested.
- send you our email newsletter (you can inform us at any time if you no longer require the newsletter);

We may use your information collected from the website to; personalise any repeat visits to our website and record visitor behaviour. We will not, without your express consent, supply your

## DISCLOSING PERSONAL INFORMATION

We may disclose your personal information to any of our employees or suppliers insofar as reasonably necessary for the purposes set out in this policy. We may disclose your personal information: (a) to the extent that we are required to do so by law; (b) in connection with any ongoing or prospective legal proceedings; (c) in order to establish, exercise or defend our legal rights (including providing information to others for the purposes of fraud prevention and reducing credit risk); (d) to the purchaser (or prospective purchaser) of any business or asset that we are (or are contemplating) selling; and (e) to any person who we reasonably believe may apply to a court or other competent authority for disclosure of that personal information where, in our reasonable opinion, such court or authority would be reasonably likely to order disclosure of that personal information. Except as provided in this policy, we will not provide your personal information to third parties.

## INTERNATIONAL DATA TRANSFERS

Information that we collect will not be processed in and transferred between other countries. Personal information that you publish on our website or submit for publication on our website or other marketing material may be available, via the internet, around the world. We cannot prevent the use or misuse of such information by others.

## RETAINING PERSONAL INFORMATION

This Section sets out our data retention policies and procedure, which are designed to help ensure that we comply with our legal obligations in relation to the retention and deletion of personal information. Personal information that we process for any purpose or purposes shall not be kept for longer than is necessary for that purpose or those purposes. Notwithstanding the other provisions of this Section we will retain documents (including electronic documents) containing personal data: (a) to the extent that we are required to do so by law; (b) if we believe that the documents may be relevant to any ongoing or prospective legal proceedings; and (c) to establish, exercise or defend our legal rights (including providing information to others for the purposes of fraud prevention and reducing credit risk).

You have the right of data Portability - to request your Personal data from us in a machine-readable format.
